TEDDICO DISTRIBUTOR TERMS AND CONDITIONS OF SALE

- 1. **AGREEMENT:** These Terms and Conditions constitute the entire agreement between TEDDICO and the Buyer and supersede all statements, representations and agreements, oral or written made by the parties or their representatives including conflicting or different provisions of Buyer's purchase order. No modification or addition to this agreement shall be binding upon TEDDICO unless specifically set forth in writing, signed by TEDDICO.
- **2. PAYMENT TERMS:** Standard distributor terms are 2%, 10th prox, net 30th day of the month. Invoices are subject to a cash discount of 2% if paid (postmarked) approximately on or before the 10th day of the month. The net amount is due by the 30th day of the month. Cash discount does not apply to transportation, special preparation or handling charges.

3. ORDER TERMS:

- **A. Minimum Billing:** Due to the cost of handling small orders, a minimum billing charge of \$100.00 will be made on all original orders.
- **B.** Additions: Additions can be made to orders already received and in process by TEDDICO. Once an order is shipped complete, no further additions can be made. Any such additions will be considered new orders for determination of freight charges and for meeting minimum billing charges.
- **C.** Cancellations: Written notification must be given to TEDDICO by the distributor to cancel an order. Orders for special or large quantities of standard items cannot be canceled.
- **D. Broken Cartons**: Product is only sold in full carton quantities.

4. SHIPPING AND FREIGHT TERMS:

- **A. Shipments:** All TEDDICO shipments are FOB shipping point. TEDDICO will use its discretion in routing shipments. As a service to its distributors TEDDICO will prepay shipping charges and include them on the invoice unless otherwise directed.
- **B.** Charges: TEDDICO will pay freight charges on all orders totaling \$750.00 or more. These shipments can be made to any destination in the continental U.S. (excludes Alaska and Hawaii). Qualifying orders to Alaska and Hawaii will be shipped freight prepaid by TEDDICO to the appropriate port of debarkation.
- **C. Backorder:** If the original order was freight prepaid by TEDDICO any and all back orders will likewise be freight prepaid.
- 5. SPECIAL SHIPPING ARRANGEMENTS: When requested by the customer, TEDDICO will ship orders via air or express service. Unless directed otherwise TEDDICO will prepay and charge all freight costs. All air and express shipments require written authorization from the distributor. Air and express shipments are not subject to minimum billing requirements.
- **6. PACKAGING:** Products will be packaged and palletized, as TEDDICO deems appropriate for protection against normal handling. If special packaging or protection is requested any and all charges will be forwarded to the customer for payment.

7. CUSTOMER CLAIMS:

A. Shortages: Discrepancies must be reported within 10 working days of shipment. Under FOB shipping point terms, title of material passes to the distributor when TEDDICO delivers the material to the carrier. It is the distributor's responsibility to resolve shortage claims with the carrier. TEDDICO's willingness to assist in these matters does not indicate an acceptance of the responsibility or any resulting liability.





- **B. Other Claims:** Claims for other errors must be made to TEDDICO within 30 days of shipment.
- C. Payment Responsibility: Any claim against TEDDICO does not alter the distributor's responsibility to pay invoices when due.
- 8. LIMITED WARRANTY AND LIMITATION OF LIABILITY: TEDDICO will repair or replace (at its option) any material delivered hereunder which under normal proper use proves to be inoperative in workmanship or material within one year of the date of shipment by TEDDICO ("Warranty Period"). The correction of inoperative material through repair or replacement shall constitute fulfillment of all TEDDICO's obligations with respect to the equipment sold hereunder. The liability of TEDDICO under this warranty for any loss or damage to the equipment or to persons or property allegedly caused by the equipment whether based on contract, strict tort liability, negligence, or warranty, shall not in any case exceed cost of correcting defects in the equipment as herein provided and upon the expiration of the Warranty Period all such liability shall terminate.

TEDDICO SHALL NOT BE LIABLE FOR SPECIAL, INDIRECT, INCIDENTAL OR CONSEQUENTIAL DAMAGES OF ANY KIND. THE FOREGOING WARRANTY IS EXCLUSIVE AND IN LIEU OF ALL OTHER WARRANTIES OF QUALITY WHETHER WRITTEN, ORAL, EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, ANY WARRANTY OF MERCHANTABILITY OF FITNESS FOR A PARTICULAR PURPOSE.

TEDDICO RETURN GOODS POLICY

Material can be returned to TEDDICO for one of the following reasons:

- **1. TEDDICO Error:** If material needs to be returned due to an error by TEDDICO, full credit plus freight costs will be issued to the distributor.
- 2. **Distributor Error:** Distributors that order material in error can return the material for immediate credit. Requests for these returns must be made within thirty (30) days of the ship date. In order for the return to be authorized, a copy of the TEDDICO invoice must be included with the return request. These returns are subject to a fifteen percent (15%) restocking charge to cover TEDDICO's costs.

Procedures to follow when requesting to return material

- **A.** All returns require written authorization from TEDDICO. A request for a Return Goods .Authorization (RGA) must be initiated through the distributor's TEDDICO sales representative.
- **B.** Material returned by the distributor must be new and unused and in original TEDDICO cartons. Returns for less than full carton quantities will not be allowed. A copy of the original invoice must accompany all requests.
- C. Unless otherwise instructed all material to be returned must be shipped according to the directions on the RGA, freight prepaid by the distributor. Returns must be made within thirty (30) days of the RGA date.
